### What we collect

### Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, technological and managerial procedures to safe guard and secure the information we collect.

## **CCTV**

Lower Broadheath Community Shop operates 24hour CCTV for the purpose of security and prevention of theft. This CCTV is not used to monitor staff work hours, and audio and video footage is stored securely for 24hours and only accessible by our two managers. #### How we use cookies

A cookie is a small file which asks permission to be placed on your computers hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you now when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.
